## Claughton Manor Brick and Tile Works Demolition of West End Brick Works, 16 June 2007

In May last year, advance road signs were placed north of Hornby along the A683. This is the very busy Hornby/Lancaster highway, leading also to M6 Junction 34. The road signs indicated From 6.00am on 16th June, a 12 hour closure will take place for the dismantling of the West End overbridge. This included the buildings holding the aerial ropeway and terminus. From observations, I took opportunity to go to this road point one week before the chaos of demolition. The 9<sup>th</sup> June came up with clear blue skies giving good views of the terminus machinery, 80 years old and to be seen on both sides of the road overbridge. In preparation for the Scrap Man Cometh, most of the buildings enclosing the machinery had, by 9th June, been removed. This made the taking of a collection of photographs easy. With time available in 2008, this mass of machinery on photo will be listed.

## **Society Research Grants**

The Committee has dealt with two applications for funding since the autumn meeting: -

A grant of £100 to the North Yorkshire Record Office towards the purchase of a map of Grinton township c1706. This map was made as part of a court case against the Wharton family initiated by Reginald Marriott and others in 1705. It shows areas of mining and hushing.

A grant to David Johnson of £672 for the archaeomagnetic dating of a clamp (lime) kiln at Kilnsey in Wharfedale. David has developed a model of technological development for clamp kilns in the dales, and dating this kiln will enable the model to be finalised. Without it, any model would be only provisional.

## **Library Report**

E-mails to the library usually ask for information, or for the loan of books or journals, however, a pleasingly large number offer additional material for the library shelves. This year I had a very special offer from Mr Les Jowsey asking if the library would like a book that was presented as a prize to his father-in-law, Mr John Walton, when he was studying at Burnley Municipal College. A copy of Harveys Colliery Electrical Engineering has duly arrived, with the presentation plate in the front. Mr Walton was awarded the book by the County Borough of Burnley in 1937, For Success in Mining Course, Advanced, 2<sup>nd</sup> Year. Mr Walton went on to work as a mining engineer with the Coal Board in London and Doncaster, and also in Chile. Thank you to Mr Jowsey and Mr Walton.

We are grateful to Rob Vernon for copies of *Earthwise* (the magazine of the British Geological Society), an off-print of his article in *De Re Metallica* on information in British archives on mining operations in Spain and Portugal, a copy of *Treatment of Disused Lead Mine Shafts:* A Guide to Good Practice, some back copies of British Mining, the 2007 Newsletter of CBA Yorkshire and two leaflets on the Porter Valley near Sheffield.

Industrial Archaeology Bulletins arrive regularly and in 2007, AIA also produced A Guide to the Industrial Archaeology of Lancashire. These County Guides always produce details of fascinating places. However, this one is also noteworthy because the word mining does not appear at all in the index - although the word lead gives information about the Anglezarke mines. Surprisingly, there are no direct references to coal; although there is a brief mention in the item on Cheesden Valley textile mills, and Aspen coke ovens are listed. (All those potential mining references missed, but Preston bus station is honoured with a photograph as well as a description!)

## Jean Tyler RIP

Members who have had anything to do with mining in the Lake District are likely to have known Jean Tyler. And those of us who did know her are definitely the richer for that privilege.

The high esteem in which Jean was held was shown by the attendance at the funeral The crematorium chapel was full to over-flowing and dozens of people were standing in the aisle and in an over-flow room. There must have been about 200 people present.

Perhaps one reason why so many people wished to pay tribute to an exceptional lady was her wonderful gift with people. Jean made everyone feel special. One day, I observed her working in the Keswick Mining Museum and dealing with a wide variety of customers coming in. She encouraged the children who tried her quiz and asked questions about the exhibits: she dealt with technical queries about mineral specimens: she was welcoming to visitors who wanted to buy pretty souvenirs: she was patient with tourists who came in with general questions about the area: she was patient with people like me who don't understand much about geology and wanted help with samples and locations. Jean remembered everyone and their interests; she would volunteer information about the places and processes in which you were interested and find exactly the right book or journal article for you. Once when I commented on this, she was typically self-effacing and just said that she was lucky in having been blessed with a good memory for names and people.

Jean died in December 2007. She had been diagnosed with a brain tumour earlier in the year and had had surgery and radiotherapy treatment. In hospital, she longed to return home and be able to look out on her beloved Lakeland fells.

After success in other careers about which Jean was always modest and would say little she and her husband Ian worked on setting up and running mining museums. The latest was in Keswick. Before that they had other museums with books as well, of course - first in Caldbeck and then at Threlkeld. The tremendous amount of work put into these successful ventures was clear to every visitor. As well as Jeans extensive knowledge of mining, she clearly had shrewd business sense.

Jean was also a driving force behind the founding and continuing good work of MOLES (Mines of the Lakeland Exploration Society). Ian Tylers books on mining in the Lake District are deservedly famous: they were joint projects, with Jean doing the illustrations and also much of the work editing the text. When in hospital, she wanted to get home to work on another volume, and had worked out how she could use her then limited physical abilities to best effect.

At the funeral, the local vicar described Jean as a lady of style. Not just her eye for the fashions which suited her; but stylish in a wider sense in her approach to life. It seems she was pleased to have

climbed Great Gable with her lipstick intact. I can envisage her at the summit smart, stylish, good fun, a knowledgeable and generous companion, with time for others ... We shall miss her.

#### Insurance

Investigating, and discussing, insurance options has taken up much of committee members time in the last year. We have investigated what other societies do; but none of the options seem to meet our needs. We have considered dividing the society into two parts; but the Committee does not recommend this. We have looked at focussed insurance; but this does not seem to be appropriate. Alan Mills has found out about becoming a Charitable Incorporated Organisation (CIO): it is not possible to do this in 2008 because full details are not yet available from the Charity Commissioners and it would require changes to our Constitution.

After discussing the risks, the Committee intends to recommend at the AGM that, for one year, the society takes out British Caving Association (BCA) insurance for Meet Leaders and for Trustees (committee members) for those who do not already have such insurance. We understand that it is possible to do this for individuals. In a years time, more should be known about CIOs and options will be reconsidered.

## **South Crofty reopening**

After many rumours that it would, South Crofty Mine looks set to reopen. The mine, which closed in March 1998 and is flooded to Deep Adit level, was bought by Baseresult Holdings Ltd in 2001.

Western United Mines Ltd will own and operate South Crofty from November 2nd 2007. Baseresult is the majority shareholder in Western United alongside Cassiterite LP, which acts for, amongst others, Galena Asset Management Ltd, a subsidiary of global commodity trader Trafigura Beheer.

Over £3.5 million will be spent by June on continuing the development. Tunnelling and exploratory drilling, begun by Baseresult last year, will continue with this injection of fresh capital bringing the total investment to £9 million. The mine will start production around the end of 2009, and the £50 million needed to make it ready has been earmarked. Staffing levels have increased from 17 to 26 and, by July 2008, will have risen to 35 full-time employees.

The company has the benefit of planning permission to extract tin from South Crofty Mine until 2042 and its planning

appeal, to bring forward the significant restoration of part of the surface area, which will assist in the early regeneration of the Pool area.

### Hemerdon mine to reopen

With global demand for tin and tungsten, Australian-based Wolf Minerals proposes to start mining the low grade wolframite deposit at Hemerdon, near Plympton in Devon.

It is hoped that the mine, which has had planning permission since 1986, will create 500 new jobs, and over about 20 years lead to the formation of an open pit about 850m long by 540m wide and 200m deep.

## **Thoresby Colliery**

The future of this 82-year-old Derbyshire mine has been secured for at least another decade after UK Coal agreed a deal, believed to be worth £200m, with power generator EDF Energy to supply coal to its power stations at Cottam and West Burton.

UK Coal is to invest £55m to develop a further 12m tonnes of coal in the Deep Soft seam close to the pit bottom. The new seam will need fewer miners and around 100 of the 500-strong workforce

is facing the axe – although there should be no job losses for two years.

Without this contract, the accessible coal would have been exhausted by 2009, but the investment gives 10 or 11 years more production and the opportunity to look for further resources.

## Welbeck Colliery

UK Coal has agreed to supply EDF with almost all of the remaining coal at Welbeck over the next two years.

## **Daw Mill Colliery**

In October 2007, UK Coal agreed a five year deal to supply power generator E.ON with almost six million tonnes of coal for its Ratcliffe station, near Nottingham. Around 75% of the coal will come from Daw Mill Colliery in Warwickshire.

## Cononish gold mine under way

Scotgold, an Australian company, has announced plans to begin mining for gold at its Cononish mine near Tyndrum, 67 km north-north-west of Glasgow. The company, which bought the mine and other exploration licences from Fynegold Exploration in May last year, has raised millions of Australian dollars to begin operations.

The site, a known gold deposit, has never been commercially mined, but it was diamond drilled and a 1.2 km long drift driven along the vein before planning approval for mining was granted in 1996. Unfortunately the price of gold fell and the project became uneconomic and spent 10 years on care and maintenance. Like Welsh gold, Scottish gold attracts a premium from jewellers because of its rarity.

"Tyndrum is no stranger to mining, and the Earls of Breadalbane mined lead there in the 18th and 19th centuries. The mines were reworked for lead and zinc ores in the early 1920s."

## Peter Geddes MBE

The Society is pleased to inform members that Peter Geddes was awarded the MBE, in the New Years Honours List, for services to industrial heritage in the Isle of Man. As a leading light in the Laxey Mines Research Group, Peter has been involved in many projects, but one of his proudest achievements was overseeing the Snaefell Wheel project which was completed in 2006."

In 1865 the Snaefell Mining Company ordered a fifty foot diameter waterwheel from Messrs Leigh and Gilbert Howell of Bagillt, Flintshire. In 1910 the then redundant wheel was dismantled and sent to a china clay pit near Bodmin, in Cornwall, where it was rebuilt and, as the Gawns Wheel, drove a plunger pump. It was later modified to drive a generator which, in turn, powered a submersible pump.

Having been abandoned in the 1950s, the wheel was eventually acquired by the Cornish Wheel Preservation Society in 1971, who dismantled it and put the components into storage. The CWPS later merged with the Trevithick Society, the wheels current owners.

In 1976, the wheel was loaned to the Llywernog mining museum with a view to rebuilding it again. This was not done, however, and in March 2003 the Trevithick Society agreed to let the wheel return to the Isle of Man. In September 2003, therefore, members of the Laxey Mines Research Group and the Trevithick Society met at Llywernog, where the wheels components were loaded onto a large wagon. It arrived on Manx soil on Sunday 21st September 2003, after being away for 93 years.

#### **Rombalds Moor**

Following criticism that it has no coordinated plan for the future use of Rombalds Moor, which includes Ilkley, Baildon, Bingley, Hawksworth and Morton Moors, Bradford Council has held a series of workshops. These have drawn together all the ideas, statutory targets, tensions and opportunities for the long term sustainable future of this unique upland area. The moor has many prehistoric and medieval remains, extensive stone quarries, (glacial) limestone pits, and coal has been mined from Millstone Grit on Rivock Edge and the Lower Coal Measures on Baildon Moor.

The December workshop, which covered Culture, Education & Heritage, was attended on behalf of the Society by Mike Gill and Martin Roe. The importance of mining and quarrying was stressed, and the council was provided with a list of ideas and concerns which are currently being used to prepare a strategy for discussion early in 2008.

# Treatment of Disused Lead Mine Shafts: A Guide to Good Practice

This fifty page guide, which was launched at the offices of Natural England in Bakewell on November 28th, has been funded by the Peak District National Park Authority, Natural England, English Heritage, Derbyshire County Council and the East Midlands Development Agency. The Society was represented by Mike Gill.

The Guide aims to provide up-to-date guidance on the treatment of old lead mine shafts for those with responsibilities for them. The importance of protecting surviving archaeology, grasses and plants around the shaft and also of maintaining access for bats are stressed. In particular it describes the statutory protection which may already be in force to protect them and advises how work should proceed. The various options for capping shafts are illustrated and discussed.

Although written specifically for the Derbyshire Peak District, the Guide will be very useful in other areas with hazards associated with metalliferous mining.

## Lion Salt Works, Marston, Cheshire

Early in 2007 I received a leaflet about the Lion Salt Works at Marston; but it wasnt until December that I managed to go to Cheshire to visit.

The Lion Salt Works date from 1894 and closed in 1986. Many of the former pan houses and other buildings remain, but most need to be made safe ready for visitors. The Salt Works Trust has managed to obtain substantial funding (but more is still needed) and significant restoration work will start in 2008. The remaining buildings will be renovated to create a working museum, which will show how salt was processed from brine by the open pan process. There are no plans to pump wild brine from the underground brine streams; but the former pump house and the nodding donkey engine will be restored.

Interpretation panels have recently been put in place by Vale Royal Borough Council and much can be seen by walking the tow-path of the adjacent Trent and Mersey canal and by looking at the buildings from Ollershaw Lane. In addition, there are a number of artefacts in the former Lion Inn which has been opened as an exhibition centre. There is an excellent video and the staff are enthusiastic and knowledgeable.

Marston is a couple of miles north-east of Northwich on the B5075. It is tourist signed from A559 and A556; but not as clearly as the Salt Museum in Northwich which is well worth a visit. Unsurprisingly, both sites are close to interesting canals and the Anderton boatlift is a short walk from Marston.

## **Threshfield Colliery**

Archaeological survey work has started in the last few days on some of the extensive coal mining remains on Threshfield Moor.

During 2005, the Coal Authority erected temporary fencing around a number of shafts and two adits near the core of the colliery, as a response to concerns about health and safety following the commencement of open access in the area.

The archaeological recording includes earthwork survey, recording of the adits and detailed examination of several of the shafts before pre-cast caps are laid.

# The Watershed Landscape: bid to HLF Landscape Partnerships

Described by Defoe as "the Andes of England", the South Pennine watershed landscape consists of gently sloping, wild, open plateaux standing high above the surrounding conurbations of Manchester, Leeds, Bradford and many other former mill towns. The area is internationally important for its heather moorlands, acid Millstone Grit rock, a wide variety and rarity of birdlife, steep wooded cloughs and traditional farming methods. There has been coal mining, stone quarrying, peat cutting plus limestone has been dug from glacial moraines. The area's many Victorian reservoirs were built to supply the growing industrial and domestic needs of the surrounding conurbations.

Because the area straddles regional and district boundaries, Pennine Prospects has been formed by its various councils, utilities and major landowners to coordinate their management policies. In July 2007, the Landscape Partnerships scheme awarded Pennine Prospects a £50,000 HLF (Heritage Lottery Fund) Planning Grant to fund the preparation of a full application to HLF in March 2008. The latter bid will comprise a landscape character assessment, access and audience development plan, training plan, as well as an overall landscape strategy and action plan. The precise area has not been fixed, but it runs from Baildon Moor in the north, to Blackstone Edge in the south, and will be confined to the upland moorlands and their fringes.

A workshop was held on December 4th in order to involve local groups. The aim of the meeting was to discuss the bid and share ideas about possible directions of work, and also to identify priority programmes and areas of activity that will address HLF's priorities. The Society was represented by Mike Gill, who would be pleased to hear from anyone working (or wishing to work) in the area.

# Recent Survey Work in Langstrothdale

English Heritage and the Yorkshire Dales National Park Authority have recently investigated and surveyed in detail the remains of drystone-walled houses and other structures, believed to be part of a complex multi period settlement and mining complex, lying high on Yockenthwaite Moor in Langstrothdale. The monument has been recognised as being of national importance for a number of years, and is protected by designation as a scheduled ancient monument.

The precise layout of the settlement remains is hard to work out because the walls of the drystone houses and their associated enclosures have collapsed into tumbled spreads of stone. This is further complicated by stone collapsing onto the site from later lead mining activity immediately upslope. It is clear from the survey that there are a number of phases of activity and development on the site.

The final survey plan is in the process of being drawn and phased, and the report written, but provisional interpretation suggests that there was prehistoric and Romano-British occupation of the complex. These remains are in turn overlain by a series of post-Roman, or possibly medieval enclosures and very small circular buildings, perhaps suggesting a seasonally occupied, transhumant settlement. The mining remains (apparent mostly as an open cut, but with evidence suggesting both earlier and later shafts) appear to be amongst the later phases of activity. At the present they are not securely dated, with suggested dating between the late medieval period and the eighteenth century.

## **Book Review**

## Silica Mine and Factory

Wainwrights Pictorial Guides are esteemed by many (and quite rightly so), however, he was not a lover of industrial archaeology. (In his book on the Coast-to-Coast walk, he recommends rushing past the Old Gang mines at 4 miles an hour!) Never-the-less, a description from his book on the north-western fells of the Lake District sent me looking for a silica brick factory. It is west of Bassenthwaite Lake at NGR NY 205 285, and marked on the OS map as a quarry (dis).

## According to Wainwright;

In the 1930s, modern plant was installed here for the manufacture of silica bricks, a mineral railway laid, the road to Wythop Hall improved and re-routed, and scores of workmen engaged. The product was not of sufficiently good quality. The buildings and plant were dismantled and taken away, the men dismissed and the site vacated.

So, one wet Lake District day, when even small fells were cloud-capped I found first the site of a ruined, possibly medieval church and then about a mile further on, substantial concrete remains of the silica brick works. Since visiting the site, Ian Tyler has written about the area and I realise that I missed the silica vein in the nearby woodland. The remains are worth seeing, but I am not sure they are worth going to see; unless you are interested in also walking the Wainwright fells or looking at ruined churches.
