Grassington Moor Lead Mining Landscape Update

English Heritage's Response to NMRS' letter written after the Autumn Meeting

At the Autumn Meeting, considerable concern was expressed about the damage being done to the lead mining remains on Grassington Moor.

Those present at the meeting authorised Sallie to write to English Heritage, the local MP, the Department of Culture, Media and Sport and the leader of the local Council. The first three replied and Neil Redfern of English Heritage has asked that his letter be made available to all NMRS members.

Dear Ms Bassham

Re: Grassington Moor Lead Mines

Thank you for your letter to Dr Simon Thurley of the 29th October 2008 regarding damage to the mining remains at Grassington, I have been asked to respond on his behalf.

Large parts of the lead mining remains are protected as a Scheduled Ancient Monument under the 1979 Ancient Monuments and Archaeological Areas Act. As you mention in your letter it is a criminal offence under the 1979 Act to undertake certain works without the consent of the Secretary of State for the Department for Culture Media and Sport. English Heritage is aware of the issues around the maintenance of the 'New Dukes Road' which crosses Grassington Moor and the use of spoil heaps as part of this work. We are currently in discussions about the management of the road and the wider industrial remains with the Shooting Estate, local landowner and National Park and hope to develop a long-term solution to some of the issues you identify in your letter.

To inform these discussions our own Archaeological Survey and Investigation Team is working with us to assess and record the features adjacent to the road and offer us advice on the impact of different maintenance works to the track. From this we hope to develop a management plan to inform future repairs and maintenance to the track and to avoid the use of sensitive spoil heaps. At this time we do not intend to take forward any legal proceedings as it is clear maintenance and management works to the track will remain necessary in the future. Our objective is to secure an appropriate methodology to undertake this work.

Initial survey work has indicated that the works to the New Duke's Road actually have some beneficial results by preventing wider damage to the monuments from water runoff after heavy rain. The survey work has also shown that since the abandonment of the industrial activity on the moor, natural process have taken over which are very hard to control without intensive management such as that which has taken place to the New Duke's Road over the years.

We remain concerned by the use of spoil heaps to repair the track but hope our approach will develop a long-term, evidence based solution to some of the management issues affecting the monument.

NMRS LATEST REPORT

Damage to Grassington Moor Scheduled Ancient Monument

During the spring and summer of 2008 unauthorised repairs were made to the road system on Grassington Moor. These works, including the removal of material from several areas to carry out repairs to the roads, have resulted in damage to the Scheduled Ancient Monument. English Heritage was told that damage was occurring in April yet it continued until at least August.

A Scheduled Ancient Monument is the highest level of designation given to an archaeological site. This means that Grassington Moor has the same level of protection as monuments such as Stonehenge.

An independent assessment of the damage has recorded events associated with the unauthorised works. These have been scored using a scale of 1 to 3; with 1 representing the most damaging events and 3 the least damaging.

A total of 130 events were recorded. 20 are classified at Level One, 15 are classified at Level Two, 93 are classified at Level Three, and two events were classified as non-damaging.

The 20 Level One events are the most damaging. These include 15 areas where mining waste has been disturbed and removed. This has affected over 700m² of ground.

This survey has pointed out that the road repairs:

- are of a poor standard many are failing already - this means that they will need re-doing soon because this was not a long-term solution
- have been carried out insensitively with no consideration for the historic importance or protected status of the site
- are directing surface water and fine material onto inappropriate areas, contaminating archaeological deposits and causing other potential problems such as directing water down a shaft, and onto scheduled structures
- have caused unnecessary damage to areas of waste tips reworked during the 20th century. These areas have had no archaeological study but in most cases have a unique physical character relating to the plant and machinery used to work them
- have caused unnecessary damage to undisturbed areas, both directly

by removal of material and indirectly by redirecting surface water.

The English Heritage Website states: "It is against the law to:

Damage a scheduled monument by carrying out works without consent Cause reckless or deliberate damage

Use a metal detector or remove an object found with one without a licence from English Heritage Conviction for these offences can lead to fines."

These works have all been carried out without consent and could be considered as reckless and deliberate damage.

If this level of damage happened at Stonehenge the public would expect prosecution. Should Grassington Moor be treated differently?
